Summary of scholarship, etc.

As a professor with a teaching-intense load (normally 80% of my workload), traditional academic research has not been a significant part of my portfolio or expectations. However, my scholarly research continues on Polish and other Slavic contemporary and popular culture, and I integrate my research into the classroom. I have also published numerous book reviews and scholarly translations, as well as articles about the classroom, for instance an essay about teaching about the Holocaust for *The Chronicle of Higher Education* ("Encountering the Holocaust through Art," *The Chronicle of Higher Education, Review*, November 21, 2014, B20), and about developing, revising, and assessing general education curricula (*Journal of General Education*, 64 (1):1-13, January 2015). I have given numerous invited lectures across the eastern states and the Midwest, as well as in Poland and Estonia. In October 2019, I presented in Bogotá, Colombia, as part of a panel entitled, "Comprehensive Engagement to Internationalization: The Case of West Virginia University," at the Conference of the Americas on International Education (CAIE-Colombia 2019).

Summary of Teaching

Since 2005 at West Virginia University, I have taught multiple sections of multiple courses each semester, normally far in excess of my assigned 4-4 load. These courses

have included Russian language courses of all levels, as well as the senior thesis courses each semester; Slavic Studies senior thesis courses each semester; and Introduction to Slavic Studies courses; at least two Honors add-on courses each semester; 1-2 writingintensive sections each semester; and 2 large-enrollment (80-150) general education foreign culture/literature courses each semester. Additionally, I have led at least one education abroad effort each year, sometimes two per year. For the past several years, my teaching and service load has ostensibly been lowered as I take on more administrative duties or have other re-assignments; regardless, I regularly teach between 8 and 12 sections per semester each year.

In addition to the regular courses I lead, I also supervise an extremely active Russian and East European Club, which conducts cultural events such as extra-curricular lectures, films, cooking nights, and fund-raisers. I also supervise the majors in Russian Studies and Slavic and East European Studies, which means course scheduling, all advising, recruiting, assessment planning, and other curricular duties. Beyond those activities, I supervise graduate teaching assistants and lecturers who teach in the programs.
